It has come to notice that apart from the aboratories mentioned above are not capturing the data relating to food testing by food testing laboratories in INFoLNET.

In view of the above, recognition of all the food laboratories other than the above 30, are temporarily kept under suspension untill further orders, as these laboratories have not implemented INFoLNET in their laboratories.
