Quality Research and Analytical Labs Pvt. Ltd., New Delhi bearing FSSAI Reg. No. 58/N/FSSAI/2019 and NABL Certificate No. TC-8118 was recognized and notified by FSSAI u/s 43(1) of FSS Act, 2006 vide Gazette Notification S.O. 3428(E) dated 18th September, 2019 for Chemical and Biological scope of testing for the purpose of carrying out the analysis of food sample under Food Safety and Standards Act, 2006 and Rules and Regulations made thereunder.

2. It is noted that Quality Research and Analytical Labs Pvt. Ltd., New Delhi has been suspended by NABL with effect from 26th October, 2023 and subsequently placed in withdrawal of accreditation category with effect from 10th December, 2023 as per the condition 2 of clause 4.5 of the NABL Document No. 216.

3. Thus, the aforementioned laboratory Quality Research and Analytical Labs Pvt. Ltd., New Delhi is hereby suspended with effect from 26th October, 2023 from carrying out analysis of samples under the Food Safety and Standards Act, 2006 and Rules and Regulations made thereunder as per regulation clause 10(2) read with clause 10(1)(iii) of the Food Safety and Standards (Recognition and Notification of Laboratories) Regulations, 2018 for a period of six months.
