

This training program was conducted to help create a set of Master Trainers in the country who in turn will deliver training and upgrade the skills of the food testing staff in India.

In continuation to this, FSSAI in collaboration with Export Inspection Council of India is organizing four days “Training of Trainers Program on Analysis of Mycotoxins” for Food Analyst and other scientific /technical personnel of Food Testing Laboratories at Export Inspection Agency, Kochi from 10th December 2019 to 13th December 2019.

In this regard, you are requested to nominate one Food Analyst/ Laboratory personnel from your laboratory who is involved in food analysis, in the prescribed application form (copy enclosed) for attending this training program latest by 18th November, 2019, at training.qa@fssai.gov.in. The participants selected for the training will be finalized by FSSAI and will be informed by FSSAI well in advance.

4. The TA/DA for participants from Government Laboratory/institutions will be borne by FSSAI as per their entitlement in their respective organizations.

5. FSSAI will reimburse the travelling expenses in accordance with the rules and as per government entitlements (kindly enclose all the original bills of accommodation, travel such as boarding pass/train tickets/bus tickets, taxi bill etc.). Reimbursement of travel by air is restricted to Air India only. It is also informed that air tickets may be purchased directly from Air India (at booking counter or website of Air India) or by utilizing the services of Authorized Travel Agents- M/s Balmer & Lawrie & company (www.balmerlawrie.com), M/s Ashok Travels and Tours and for railway tickets only through IRCTC (www.irctc.co.in).
