Latest News of FSSAI

- The draft FSSAI Rules forwarded to the Health Ministry for notification. The rules are framed for a governance structure of FSS Act, roles of different implementing agencies. On the basis of extensive consultations and regional workshop, State Governments have been sensitized to the provisions of the new FSS Act as well guided on the steps to be taken by them. During 2011, FSSAI shall closely work with each State to effect the transition from prevention of Food Adulteration Act (PFA) towards new Food Laws (FSS Act), designate new functionaries, introduce various new provisions of t and help upgrade their regulatory institutions.
- The recent earthquake in Japan and concerns of possible radiation leakage from affected nuclear plants, there is a need to increase the surveillance of food imports from Japan to ensure that they are safe for consumption. As a precautionary measure it has been decided to test samples of food articles, particularly fresh produce, exported from Japan after 11th March, 2011, such as seafood, fruits, vegetables and meat for radioactive contamination.
- NISG (National Institute of Smart Governance) parting FSSAI in drafting import Rules and Regulations, development of MIS for clearance for imported food.
- EOI floated for empanelment of NABL accredited labs for testing imported food samples.

6. Two Day Workshop on Implementation of Sevottam and Elements of IS- 15700

Two day workshop on 15th-16th November 2010 at FSSAI's Headquarters to enable FSSAI employees to understand the concepts of Sevottam, followed by one day workshop on 25th November 2010, were organized by FSSAI.

7. Interactive meet with stakeholders on Imported Food clearances

All major stakeholders participated in the session on 15th Feb 2011 at Headquarter FSSAI, Delhi. Representatives from Customs Airport authority, CHA, DGFT, Ministry of Shipping, Export/Import association etc.

C. <u>LABORATORIES: GAP STUDY AND</u> <u>STANDARDS</u>

A MOU signed between Quality Council of India (QCI), and FSSAI on 24th April, 09 for conducting gap study of the Government public health/food laboratories. QCI has audited a total of 44 labs till August 2010. The gap study was conducted as per guidelines of ISO/IEC: 17025:2005 (General requirements for the competence of testing and calibration laboratories). It includes following areas:

- a. General Chemicals
- b. Pesticide Residue, antibiotic, heavy metals, veterinary drug residues etc
- c. Microbiology

FSSAI shall explore the options of involving suitable agencies for assisting laboratories for up-gradation. A suitable MOU will be developed with the State Governments to identify and fix responsibility for suggesting steps which are required to be taken by them.

Standards for Labs

State public/food laboratories are to follow entry level standard for the testing of samples and their documentation. This would be the first step in the progress towards achieving accreditation as per ISO/IEC: 17025:2005. They have to reach this standard in a span of one year and to the final standard in a span of three years for final notification under Section 43 of Food Safety Standard Act. The entry level standard will act as a base for getting the accreditation Board of Laboratories (NABL) or any other recognized bodies.

D. <u>INTEGRATED</u> IMPORTED FOOD SAFETY SYSTEM (IIFSS)

National Institute for Smart Government (NISG) engaged by FSSAI for conceptualization, design and implementation of an Integrated Imported food Safety System (IIFSS) for ensuring that food imported into India is safe.

NISG also helped FSSAI to operationalise Imported Food Clearance process at the following Sea and Air Ports during last few months.

- 1) Chennai Sea and Air Port
- 2) Mumbai Sea and Air Port Trust, Mumbai,
- Jawaharlal Nehru Port Trust, Nhava Sheva, Mumbai,
- 4) Kolkata Sea and Air Port Trust, Kolkata and
- 5) Haldia Dock Complex, Purba, Mednipur, WB
- 6) New Delhi Air Port
- 7) Tuglakabad ICD, Dadri ICD.

A "Kick-off" meeting was held at each location with the involvement of all stakeholders during August, 2010. FSSAI has notified Authorized Officers under section 47 (5).



The imported food safety process includes the following steps:

- 1. Sampling request from Custom House Agents
- 2. Sampling of food item according to its hazard
- 3. Submission of sample to lab for testing
- 4. Receipt of lab report
- Submission of No Objection Certificate (NOC) to customs for clearance of food import
