**NOTICE (DR-01/2021)**

**Subject: Short listing of candidates for interview for the post of Deputy Director (Specialisation : Admin and Finance) - Advt. No. DR-01/2021), FSSAI - reg.**

Food Safety & Standards Authority of India (FSSAI) had conducted written examination on 25<sup>th</sup> July, 2021 for various Group 'A' posts in FSSAI against recruitment notice DR-01/2021. The selection to the posts is to be based on the combined score of written examination and interview, wherein the weightage of these stages is 85% and 15% respectively. Based on marks scored in the written examination candidates in the ratio of 1:10 were asked to submit the eligibility documents vide letter No HR/1/2021-HR-FSSAI dated 22 December 2021.

2. Based on the marks scored in the written examination and prima-facie verification of eligibility, candidates in the ratio of 1:5 as per merit have been short listed for interview. Category wise cut off marks for shortlisting for interview is as under :-

- (b) Cut-off marks for OBC – 28
- (c) Cut-off marks for SC - 21
