#### **NOTICE (DR-01/2021)**

Subject: Submission of Documents for prima-facie verification of eligibility for the Post of Joint Director, Deputy Director, Senior Manager (IT) and Manager (Advt. No. DR-01/2021), FSSAI - reg.

Food Safety & Standards Authority of India (FSSAI) had conducted written examination on 25<sup>th</sup> July, 2021 for various Group 'A' posts in FSSAI against recruitment notice DR-01/2021. The selection to the posts is to be based on the combined score of written examination and interview, wherein the weightage of these stages is 85% and 15% respectively. Score card of candidates have already been hosted on our website.

- 2. It has been decided to invite the candidates in the ratio of 1:10 for submission of documents for the posts of Joint Director, Deputy Director, Senior Manager (IT) and Manager for prima-facie verification of eligibility. First the eligibility of candidates in the ratio of 1:5, as per merit, would be verified and the documents of remaining candidates (in sequence as per merit) would be verified subject to any candidate from 1:5 ratio found ineligible in terms of eligibility criteria i.e. age, educational qualification, relevant experience, Pay scale/ CTC etc as mentioned in the advertisement. Based on marks obtained and verification of prima-facie eligibility, candidates in the ratio of 1:5 as per merit would only be called for interview. Candidates may note that merely submission of documents for prima-facie verification and appearance of roll number in the list (Annexure-B) does not bestow the right for being called for interview.
- 4. All the candidates, whose roll numbers are mentioned in Annexure 'B' are required to send legible scanned copies of all the documents (as per list below) for verification of their eligibility. The list of documents in chronological order are given below: -

7	<b>Experience Certificate</b> : Certificate from the Employer in support of having possessed relevant experience as per advertisement, as on the date specified in the said recruitment notice for the post. The experience certificate must contain post details, date of joining, date of relieving, nature of experience, Pay Level/Grade Pay/CTC, etc.
8	Pay Scale/Grade Pay/IDA scale/Cost to Company as specified in the Recruitment Notice
9	Documents/Certificate substantiating status related to Ex-Servicemen in support of your claim for availing age relaxation, if applicable.
10	Female candidates who have changed their First/Last/Middle Name after marriage shall produce Gazette Notification/their original Marriage Certificate/affidavit in original.
11	Any other relevant documents in support of eligibility to Educational Qualification, Relevant Experience and Pay Scale/Grade Pay/IDA scale/Cost to Company as specified in the Recruitment Notice.
12	Currently valid photo identity proof (PAN, Aadhar Card, Permanent Driving License, Passport, Voter's Card).  Please note – Ration Card and Learner's Driving License will not be accepted as valid ID Proof.
12	Photocopy of e-Admit Card of written examination conducted on 25 <sup>th</sup> July, 2021 duly signed by Examination Centre Supervisor.
13	System generated printout of the online application form.
14	Self Declaration as per Annexure-'A'.

In case it is not possible to send the documents as single PDF due to file size limitation, the same may be forwarded in parts. The candidates shall mention the subject of email as:-
