Food Safety and Standards Authority of India conducted the computer based test from 24.07.2019 to 26.07.2019 for Assistant Director, Deputy Manager and Administrative Officer advertised against DR-02/2019. Written examinations for these posts were conducted on 10th & 11th October, 2020. Post-wise details of candidates appeared in the written examinations are as under:

The selection to the posts of Assistant Director, Deputy Manager and Administrative Officer is to be made based on the combined score of CBT+ Written Examination + Interview whereas the weightage of these stages is 50%+ 35%+15% respectively. Based on marks scored in Computer Based Examination and written examination, candidates have been shortlisted in the ratio of 1:5, category-wise, to appear in interview. Separate cut-offs have been fixed for these posts category-wise. The post-wise cut-offs applied and the candidates available for each category are given in the Tables below:


