1.0 **SUBMISSION OF BID:**

1.1 a) Submission, acceptance and rejection: - A tender in sealed cover super scribing "Tender for supply of around 63"LED SMARTFULLY HD TV should reach in the office of Asstt Dir (GA), Food Safety and Standards Authority of India, 3rd Floor, FDA Bhawan, Kotla Road, New Delhi.-110002 on or before 1100 hrs by 10th Feb, 2017.

2.0 Non-transferability: This tender is non-transferable.

3.0 DETAILS OF LED TV REQUIRED TO BE SUPPLIED

4. **Firm's Registration:** Bidder must have valid PAN, Service Tax, TIN/VAT Registration so as to ensure that it meets all statutory tax obligations and there would be no evasion/loss of tax to the govt.

5. The person signing the tender document should be an authorized person to submit quotation on behalf of the agency/firm/dealer, in case other than the owner/director/Managing Director.

6. The financial bid/details should be quoted in an unambiguous form clearly stating price, taxes and allied other charges, if any. Figures in Indian Rupees (in numeric as well as in words are required to be mentioned).

6.1 In case no mention is made towards Taxes, Custom Duty, if any, Excise/VAT etc; the price quoted shall be considered as inclusive of all application statutory taxes and no consideration thereafter under any circumstances shall be entertained.

7. Bid Opening

- 7.1 Bids will be opened on same date i.e. 10th Feb, 2017 at 1200 hrs.
- 7.2 Authorized representative may attend the meeting, if they wish to. The authorized representative must be competent and empowered to settle all issues, if required.

8. **EVALUATION CRITERIA:**

- 8.1 Eligibility of tenderer will be based on resource availability and an early supply of requisite item i.e. TV. and submission of clear price details and delivery time.
- 8.2 No error, overwriting / correction shall be permissible unless attested under the signature of the bidder with date and seal.

9. <u>Evaluation of bids</u>:

- 9.1 The Authority may reject all bids if they are found to be unresponsive or unsuitable either because they represent deficiencies in complying with the enquiry or they involve substantively higher cost.
- 9.2 In case two bidders quote equal price the bidder offering quick delivery shall be declared successful. However, the decision of this organisation will be final and abiding on the bidders.
- 9.3 Validity of Tender: Tender shall be valid for acceptance for a period not less than 30 days after tender opening date.

10.0 Award of Contract:

- 10.1 FSSAI will award the contract to the tenderer whose tender has been determined to be substantially responsive.
- 10.2 By the process of evaluation of bids, the Evaluation Committee prepared ranking list of bidders and awarded the contract to the L-1 bidder.

11. FORCE MAJEURE

11.1 In the event of either party being rendered unable by Force Majeure to perform any obligation required by them under the contract, the relative obligation of the party affected by such Force Majeure shall be suspended for the period during which such cause lasts. It is clarified that in case, the Force Majeure event occurs due to negligence of agency, then the provisions of this clause shall not apply to the agency. 11.2 Upon the occurrence of such cause and upon its termination, the party alleging that it has been rendered unable as aforesaid thereby, shall notify the other party in writing within 07 (Seven) days of the alleged beginning and ending thereof giving full particulars and satisfactory proof. If deliveries are suspended by Force Majeure conditions lasting for more than one week, FSSAI shall have the option of cancelling this contract in whole or part at its discretion without any liability on its part.

12. APPLICABLE LAW AND JURISDICTION

All matters connected with this work shall be governed by the Indian law both substantive and procedural, for the time being in force and shall be subject to the exclusive jurisdiction of Indian Courts at Delhi.
