GENERAL:

1.0 Tenderers are advised to acquaint themselves fully with the description of work, scope of services, time schedule and terms and conditions including all the provisions of the tender document before framing up submitting their tender.

SITE PARTICULARS

1.1 Tenderers may inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to nature of work, site conditions, means of access to the site etc. Non-familiarity with the site conditions will not be considered a reason either for extra claims or for not carrying out the work in strict conformity with the specifications. For site visit and any clarification/information/Assistance, the intending tenderers may contact the Assistant Director (GA), 3rd Floor, FDA Bhawan, Kotla Road, New Delhi-110002 on any working day between 1000hrs-1600 hrs (telephone no.23237442). The prospective bidders may give their suggestion for improvement, if considered appropriate for the benefit of user.

SUBMISSION OF TENDER/BID:

b) The tender will be submitted in two parts as under: -

(i) Technical Bid – Technical Bid consisting of all technical details along with supporting documents as per the check list and as specified in tender document except the price bid.

(ii)Financial Bid – Financial Bid indicates item-wise price for the items mentioned in the technical bid. This part shall contain the total price to be charged by the tenderers for executing the work, complete in all respects including applicable taxes. Sealed envelope containing this part shall contain only **PRICES** and no conditions i.e. deviations/assumptions/stipulations/clarifications/comments/any other request whatsoever.The buyback offer price of existing old lifts qty 02 Nos make ECE will be indicated and deducted from the total price quoted for the new lifts. The bidders may inspect the lifts for assessment on any working day between 1000 hrs to 1700 hrs.

Note: The technical bid and the financial bid should be sealed by the bidder in separate covers duly super-scribed as 'Technical Bid' or 'Financial Bid', as the case may be, and both these sealed covers are to be put in a bigger cover which should also be sealed and duly super-scribed as "Tender Documents in response to Tender Notice dated_____October, 2016 forsupply of two new lifts atFDA Bhavan, New Delhi. DD/Pay Order for EMD should be placed inside the sealed envelope for technical bid.

2.Tenders, which are not complete in all respects, are liable to be rejected. The FSSAI reserves the right to reject all or any tender wholly or partly without assigning any reason whatsoever.

2.01 While submitting the Tender, the tenderers will be deemed to have read, understood and accepted all the terms and conditions stated in the tender documents. Any doubt or clarification with regard to the interpretation of the terms and conditions stipulated in the Tender Enquiry may be got clarified from FSSAI Hqrs mentioned above at least 05 days before tender closing date.

3.0 Bidder's Eligibility Criteria (BEC)

- 3.01 The bidder should be in case of a Contractor/Agency/Firm (empanelled with CPWD), a Lift Manufacturing Company/Firm on Design, Manufacturer, Supply, Installation, Testing and Commissioning of Lifts having minimum five years' experience in the field & having been incorporated atleast five years prior to the date of issue of tender document (Supporting documentary evidence should be submitted along with the bid).
- 3.02The bidder must be registered with State / Central Government for Service tax /VAT/TIN and must be in possession of Permanent Account Number (PAN).
- 3.04 Experience: Bidder firms are required to submit documentary proof of having executed at least three similar jobs of value of not less than Rs.40 lakhs each in Central/State Govt, Public Sector Undertaking/Autonomous bodies and Large Private Sector Unit during the last three years (separate work orders with successful completion of the assigned work be submitted). The period of three years will be reckoned from the date of issue of this tender. Execution certificates issued by the user organizations in support of their credentials are to be enclosed.
- 3.05 The bidder should not have been blacklisted by any Central/State Government or its agencies and no investigation should be pending against it by any

Government/Government Agency on account of use of corrupt/unfair trade practices. A Certificate to this effect is required to be submitted by the bidder.

3.1 **Financial eligibility Criteria**:

- 3.1.1 <u>Annual Turn Over</u>: Turnover of the bidder firm should not be less than Rs.150lakhs per annum during each of the preceding 3years (a) 2013-2014 (b) 2014-2015, (c) 2015-2016. Financial statements viz Trading/Profit & Loss Account, balance sheet etc. for the previous three financial years along with the copy of ITR (Income Tax Return)duly certified by the Chartered Accountant may be furnished in Annexure-3. If the same is not available for FY 2015-2016, the same may be submitted for 2012-2013 with specifying reasons there for.
- 3.1.2 The bids not meeting the above requirements of BEC / Tender documents entirely and / or not accompanied with necessary documents shall be summarily rejected & shall not be considered for detailed evaluation.
- 3.1.3 A check list for submission of the relevant documents is enclosed as Annexure -7. Bidders are requested to ensure that all documents as per the check list are enclosed while submitting the offer. Duly filled in check list is also required to be submitted.
- 3.1.4 Tenderers are advised to submit the tender strictly based on the terms and conditions and specification contained in the Tender Document and not to stipulate any deviations. Conditional tenders are liable to be rejected.

4.0 <u>Scope/Description of Work</u>

The FSSAI intends to procure/install two new lifts with 10 passengers (680 kg weight) carrying capacity each by replacing the existing old ECE make lifts having 8 passengers carrying capacity (544 kg weight), with the best available technology and quality using Gearless & Machine Room Less (MRL) system with fully functional ARD (Automatic Rescue Device). The Existing Machine Room utilised for travelling/bringing Lift on 5th Floor would be bv creating/modification of required space/infrastructure. The selected bidder may carry out civil work if it has the resources available (separate proposal for the same may be submitted). The Technical Specifications for the proposed Lifts are given below as an indicative and the essentially required specifications to be adhered to by the lift manufacturers as per present norms/rules/guidelines/circulars issued under (i) The Indian Electricity Rules 1956 (ii) The Indian Electricity Act 1910 (iii) Bombay Lift Act 1939 (iii) Delhi Lift and Escalator Bill (iv) Haryana Lifts and Escalator Act-2008 (v) Fire safety regulations pertaining to lifts (vi)NBC provisions applicable to lifts-2005 etc.

The bidders shall also take into account the applicable local and State regulations for the design and installation of lifts. Wherever appropriate Indian Standards are not available, relevant British and/or IEC Standards shall be applicable. BIS certified equipment shall be used as a part of the Contract.EN-81 standards as amended to date would be used as a benchmark where appropriate IS are not available.

5.0 Other specific Conditions regarding scope of work:

5.1. The existing lift machinery including all accessories shall be dismantled by the selected bidder charges shall be payable and no extra in anv form for dismantling/removal/transportation. The buy back cost of existing lifts (qty 02 Nos with 8 passengers 544 kg capacity each) shall be indicated separately and deducted from the price of new lifts thereby offering the net amount payable to the successful bidder by FSSAI. It will be the responsibility of the selected bidder to take care of all repairs/civil/electrical etc; whatever damages are done while executing the job. All such works/items shall be done by the selected agency without any additional cost. The existing Machine Room would therefore be utilised for brining/travelling of new lifts on top (i.e. 5th Floor) and whatever civil/electrical work required to be carried out the same shall be prescribed/specified by the selected bidder.

5.2 The new lifts would be selected from the following acceptable Makes/Manufacturers & the decision will be the sole descretion of FSSAI and no query/explaination on this count shall be given:-

5.3.The entire job is required to be undertakn by the selected bidder on a Turnkey basis. The work shall comprise of entire labour including supervision and all materials necessary to make a complete installation. Any item required for completion of the project but left in-advertatently shall be executed within the quoted rates without any delay.

5.4. It will be the responsibility of the Tenderer to arrange for the inspection for the issue of lift license required for the use of passengers before putting the lift into service and handed over for use to FSSAI and shall be responsible for any kind of lapse whatsoever, if any.

5.5. The Lift shall be under guarantee/comprehensive warranty maintenance free of cost (inclusive of all spares and labour) of the sucessful bidder for a period of 24 months from the date of issue of Lift license from statutory authorities . FSSAI shall not make any payment on any maintenance during the warranty period including attending the breakdown calls for fault rectification. The selected Company, however, also require to undertake Annual Maintenance Contract for a period of five years which shall be commenced after completion of 24 months period.

5.6. The bidder shall be responsible for any injury or damage caused to the workmen deployed at site for carrying out the work and FSSAI in no way shall be held responsible for the same. The bidder shall indemnify FSSAI from any type of irregularity, labour & industrial acts/disputes, compensations, min wages etc. which law of land may attract/applicable in the process of removal of existing lifts and installation and commissioning of new lifts.

5.7. All works shall be carried out in acordance with the relevant regulations , both statutory and those specified by the Indian Standards related to the works covered by tenderer.

5.8. The installation shall be carried out in conformity with the Delhi Lift Act. In addition the corrective measures/regulations shall also be kept in mind in this regard applicable under(i) The Indian Electricity Rules 1956 (ii) The Indian Electricity Act 1910 (iii) Bombay Lift Act 1939 (iii) Delhi Lift and Escalator Bill (iv) Haryana Lifts and Escalator Act-2008 (v) Fire safety regulations pertaining to lifts (vi)NBC provisions applicable to lifts-2005.

5.9. Designing, manufacturing, testing, installation and maintenanceof the lift installations should be in accordance to the relevant IS Codes as appended in Appendix –IX of General Specifications for Electrical Works (Part III Lift and Escalators) -2003 with upto date correction slips, if any.

5.10. The FSSAI reserves right to inspect the fabrication job at factory and the successful tenderer has to make the arrangement for the same. The successful tenderer shall give sufficient advance notice regarding the dates proposed for such inspection to the FSSAI representative .

5.11.Detailed terms and conditions shall be part of the contract to be signed with successful bidders.

6.0 <u>Technical Bid</u>

Technical Bid consists of EMD and all technical details such as Details of Company; Its turnover, experience in execution of similar work, details of registration with VAT, Service Tax authorities, PAN etc. along with supporting documentary evidence. All Documents should be on the letter head of the Bidder.

Note:-It is made clear that no part of Price bid should be reflected or disclosed in technical bid in any manner. In case it is so found, the tender will be summarily rejected by FSSAI.

6.1 Tender fees: Cost of tender fee is Rs.500/- (non-refundable) payable in the form of cash at time of obtaining blank tender document or in cases of downloaded form from the website, by way of Demand Draft / Pay order drawn on any Nationalized Bank/ scheduled commercial bank in favour of Senior Accounts Officer, FSSAI, payable at New Delhi 110002.

6.2 **Earnest Money Deposit (EMD) / Bid Security:** Earnest Money Deposit is Rs.1,00,000/-(Rupees One Lakh only) (non-interest bearing). The EMD shall be paid in the form of demand draft / banker's cheque/Bank Guarantee issued by a nationalized bank /Scheduled Commercial Bank in an acceptable form in favour of Sr. **Accounts Officer, FSSAI** payable at **New Delhi**.

6.3 Tender offers received without EMD shall be rejected summarily and will not be considered under any circumstances. EMD of tendering agency who submit the sealed quotation but withdraw the same before expiry of the tender validity date may be forfeited at the discretion of FSSAI.

6.4 The person signing the tender document on behalf of the agency, shall attach with the tender a proper power of Attorney, duly executed, stating that he has the authority to bind the company in all the matters pertaining to the contract, including the arbitration clause.

7.0 **Financial Bid**

7.1 Financial bid should **quote Unit rate of description of goods** (in quantity) in the format, Annexure – 5. The figures should be in Indian rupees (in words also). Incomplete bids will not be considered and are likely to be rejected.

7.2 Rates quoted shall be inclusive of **all statutory duties and taxes** (including excise and customs, Service Tax, octroi, VAT etc. and all charges for packing, forwarding, insurance, freight and delivery, installation, testing, Commissioning etc. at site, overhead charges, general liabilities/obligations and clearances from local authorities. Price quoted shall be firm and any variation in rates, prices or terms during the validity of the offer may lead to forfeiture of the EMD.

7.3 Rates for AMC are also to be quoted separately as per bid proforma (Part-II of Annexure-5). However, that shall not be considered for inclusion in Contract Value. The Contract Value will be the total cost of New Lifts as per prescribed format (i.e. Annexure-5 Part-I).

7.4 No corrections or overwriting will be entertained in schedule of rates by using correcting fluid. All corrections should be duly initialed.

10.2 The Technical Evaluation Committee will scrutinise the technical bid in presence of authorised representatives, if anyone present, and evaluate the eligibility of tenderer based on various eligibility criteria as specified in tender document such as firm being a lift manufacturing firm with at least 5 years' existence, proof of past experience, financial capability, resource availability etc. The committee would consider the tender documents and satisfy themselves about the capability of the tenderer firm to carry out the scope of work to entire satisfaction of the authority.

11 Financial Bid

- 1.1 The commercial offers will be opened only in respect of bidders who qualify technically on consideration of their technical bid. The technical bid not meeting the minimum technical requirements as per the tender documents shall be rejected.
- 11.2 The bidders who qualify at the technical evaluation stage shall only be called for opening of financial bids. FSSAI shall intimate the bidders, the time/ venue for the financial bid opening through email or telephone.
- 11.3 In case bidders are found technically qualified after technical evaluation, the bidder will be selected based on price offered and relevant factors. However, the FSSAI reserves the right not to award the contract to L1 bidder for any valid reason to be recorded therefor and in case the particular brand/make of Lift is selected by the buyer (FSSAI) it may award the contract accordingly subject to it is considered appropriate and for the better quality product & also in terms of popularity and after sales services.
- 12 **Validity of Tender Offer:** Tender submitted by bidders shall remain valid for acceptance for a minimum period of 120 days from the date of opening of the tenders. The bidders shall not be entitled during the said period of 120 days to revoke or cancel their Tender or to vary the Tender given or any term thereof. In case of tenders revoking or cancelling their tenders or varying any terms in regard thereof, FSSAI retains the right to forfeit Earnest Money paid by them along with their tender without giving any notice. Further, the financial offer shall remain unchanged till successful completion and handing over the Lifts to the concerned FSSAI official(s).

13Rejection of tenders

FSSAI reserves the right to reject all bids if these are found to be unresponsive or unsuitable either because these represent major deficiencies in complying with the tender requirements or these involve substantively higher cost or for some other reason as the authorities may deem proper.

14.0 Award of Contract:

- 14.1 The successful bidder shall be required to furnish a Performance Security (an amount of 10 % of the total value of the contract) in the form of Account Payee DD / Fixed Deposit receipt or Bank Guarantee from a Scheduled commercial bank in an acceptable form (Annexure- 6).
- 14.2 The Performance Security shall remain valid for a period of sixty days beyond the date of completion of all contractual obligations.
- 14.3 Failure of the successful bidder to comply with the requirements of above clauses shall constitute sufficient grounds for the annulment of the award and forfeiture of Bid Security.

- 15.0 **Completion period of the work:** The successful bidder shall be required to complete the entire work of planning, designing, supplying, installation, testing, commissioning and handing over of the entire system to the satisfaction of FSSAI within 6 months from the date of award of the contract.
- 16.0 **Guarantee** All equipment shall be guaranteed for a period of 24 months from the date of taking over the installation by the FSSAI against unsatisfactory performance and/or break down due to defective design, workmanship of material. The equipment or components, or any part thereof, so found defective during guarantee period shall be repaired forthwith or replaced free of cost, to the satisfaction of the FSSAI. In case it is felt by the FSSAI that undue delay is being caused by the bidder in doing this, the same will be got done by the FSSAI at the risk and cost of the contractor. The decision of the FSSAI in this regard shall be final.
- 16.1Periodical Service for the first 12 months will be carried out after the lift has been handed over or offered for inspection.
- 16.2 The Comprehensive Annual Maintenance Contract will also be required for a period of three years after the expiry of guarantee period of 24 months from the date of taking over the installation of lifts. The price for the same may also be quoted by the prospective bidders in prescribed format attached as Part-II of Annexure-5 of this RFP.

17. FORCE MAJEURE

- 17.1 In the event of either party being rendered unable by Force Majeure to perform any obligation required by them under the contract, the relative obligation of the party affected by such Force Majeure shall be suspended for the period during which such cause lasts. It is clarified that in case, the Force Majeure event occurs due to negligence of agency, then the provisions of this clause shall not apply to the agency.
- 17.2 Upon the occurrence of such cause and upon its termination, the party alleging that it has been rendered unable as aforesaid thereby, shall notify the other party in writing within 07 (Seven) days of the alleged beginning and ending thereof giving full particulars and satisfactory proof. If deliveries are suspended by Force Majeure conditions lasting for more than 2 (two) months, FSSAI shall have the option of cancelling this contract in whole or part at its discretion without any liability on its part.

18. APPLICABLE LAW AND JURISDICTION

All matters connected with this work shall be governed by the Indian law both substantive and procedural, for the time being in force and shall be subject to the exclusive jurisdiction of Indian Courts at Delhi.
