#### **CIRCULAR**

Subject: Filling up of the posts Sr. Private Secretary in Food Safety and Standards Authority of India on deputation – reg.

The Food Safety and Standards Authority of India (FSSAI) is an autonomous statutory Authority set up under the Food Safety and Standards Act, 2006 for laying down science based standards for articles of food and to regulate their manufacture, storage, distribution, sale and import, to ensure availability of safe and wholesome food for human consumption.

- 2. The pay, tenure of the officials selected on deputation will be governed by provisions laid down in the Department of Personnel and Training's OM No, 6/8/2009-Estt. (Pay-II) dated 17.06.2010, as amended from time to time.
- 3. The initial period of deputation in FSSAI shall be three years. The period of deputation, in case of employees already on deputation in another ex cadre post including, the period of deputation held immediately preceding this appointment in the same or some other organization/Department shall not exceed five years. The maximum age limit for appointment on deputation shall be 56 years on the last day of receiving the applications.
- 4. Officials appointed on deputation to Food Safety and Standards Authority of India are eligible to retain the general pool residential accommodation allotted to them in accordance with Ministry of Urban Development, Directorate of Estates letter no.11013/D/6/2008-Pol.I dated 27th February, 2008 for a period of 5 years from the date of establishment of the Authority.
- 5. It is requested that wide publicity may be given to the vacancy circular amongst staff under your administrative control and, applications in the given proforma (Annexure II) along with complete and up to date CR Dossiers of the officers who can be spared in the event of their selection, may be sent to this Authority. While forwarding the applications, it may also be verified and certified that the particulars furnished by the officers are correct and no disciplinary proceedings are either pending or contemplated against him/her. The integrity of the officers may also please be certified. It may also be confirmed that no major/minor penalty has been imposed on him/her.
- 6.
